



- iii) The assets and liabilities of the Trust shall vest in the Board of Trust and the Board of Trust shall hold, acquire, take care and manage all the property, assets, liabilities, incomes, receipts, expenditures and outgoings of the Trust in the manner as decided by the Board of Trust by majority.

It's Power and function will be wide and pervasive and it shall be overall responsible for the management of affairs, activities, deeds and actions of the Trust and in so doing the guidelines and the decisions of the board of trust shall be binding on all the trustees of the trust are concerned.
